

New for 2017 will be a revamped Golf Saskatchewan website. The plan for golf in Canada was to have a system like a professional sports team. Through the IOC grant, this is coming into full gear for 2017 with the launch of Golf SK website. The address will remain the same but the look will be fresh and fully mobile ready.

Golf Course Visitation Program

In 2017, club visitations will continue to be a priority. In 2016, we had 14 specific course visitations which was a slight decrease from the 22 visitations in 2015. If your club would like a Course Visit from Golf SK, please call our office to inquire. We can address certain issues/challenges a club may have, take pictures of the golf course for promotional purposes, and meet the individuals who are working to make your facility a successful golf club.

Membership Assistance Program (MAP Grants)

MAP is funded by the Saskatchewan Lotteries Trust Fund through the proceeds of lottery ticket sales in Saskatchewan. Since we began tracking the distributed MAP GRANTS funds in 2001, more than \$1.1 million dollars as been allotted to member clubs of Golf Saskatchewan. Golf Courses and Clubs registered with Golf Saskatchewan are eligible to apply for funding through the Membership Assistance Program (MAP). The MAP Grant funding provides direct financial assistance to benefit sport development at the club and community levels.

In 2016, Golf Saskatchewan distributed \$95,200 in MAP Grants to 61 member clubs. A complete break-down of the clubs and the MAP funding from 2016 can be found in the audited financial statements (Schedule 7) in Appendix 1. In 2017, \$96,500 will be distributed to Member Clubs. The details about the Spending Plan application deadlines and overall procedures will be communicated to the clubs.

Value Added Program (VAP)

The Value-Added Program is a program providing another opportunity for a golf courses and other businesses to market themselves to golfers throughout the province. Our member golf courses offer playing incentives to members traveling to play their golf course. Players simply present their Golf Saskatchewan/Golf Canada membership card or their Golf Canada Score Centre app at a participating golf course and qualify for an instant benefit. Value Added Participating Clubs are listed on our website with the incentives they are providing for the current year.

FINANCE COMMITTEE

I am pleased to present the financial report for 2017 for the year ending Dec 31st, 2016. The firm of VIRTUS GROUP has completed the annual audit of the financial statements of Golf Saskatchewan and in their opinion management maintains a sufficient and appropriate system of internal accounting controls to ensure the transactions are accurately recorded on a timely basis, are properly approved and result in reliable financial statements. Management and the Board of Directors acknowledge the financial statements are their responsibility.

The Finance Committee, composed of members of the Board of Directors, meets with the management of Golf Saskatchewan to ensure accuracy of the associations financial reports. The Board of Directors has voted to approve the financial statements as presented in the Appendix I of the annual report.

Financial highlights:

- i. *Revenues* increased approximately 7% or \$60,000 from the previous year.
 - o Several grants were successfully received, increase in Sask Sport Funding, championship participation was up and membership dues increased.
- ii. *Expenses* decreased approximately 1% or \$5,000 from the previous year.
 - o Decrease in Marketing & Promotional Expenses as well as meeting expenses

The Expenses are detailed below:

- iii. *Administration (Schedule 3)* basically flat 0% or \$950.
 - o A normal year of operations.
- iv. *Capacity and Interaction (Schedule 4)* decreased approximately 12% or \$5,700.
 - o Savings in the Marketing & Promotion and Golf SK meetings.
- v. *Participation and Interaction (Schedule 5)* increased approximately 1% or \$900.
 - o Provincial championship cost savings,
 - o Officials development expenses were less for the Rules of Golf Seminar
- vi. *Excellence (Schedule 6)* increase approximately 13% or \$12,00.
 - We spent more on national championships and athlete assistance in 2016 due to the location of 3 national championships.
 - o More money was invested in Coaching Development & Training Opportunities in 2016

The overall result is a *\$58,931 surplus* of revenues over expenses and therefore an increase in the reserves (unrestricted net assets).

NOTES:

- 1. At the time of budgeting, the board and management does not include any grant revenues unless they have officially been announced and received by the office.
- 2. In 2016, the Board of Directors approved a strategic deficit budget of \$4,174 (with expenses totaling \$888,774 compared to revenues of \$884,600). An approved deficit budget does not impact Golf SK's overall financial position due to our strong reserve funds and no interest is accounted for in our general operating funds.
- 3. On the next page please view the approved high-level budget for 2017 and a snapshot of the strategic draft budgets for 2018 & 2019.

HANDICAP COMMITTEE

Purpose of the Golf Canada Handicap System

The purpose of the *Golf Canada Handicap System* is to make the game of golf more enjoyable by enabling players of differing abilities to compete on an equitable basis. The System provides a fair *Golf Canada Course Handicap* for each player, regardless of ability, and adjusts a player's *Golf Canada Handicap Factor* up or down as the player's game changes.

An essential element of the *Golf Canada Handicap System* is the requirement that each *Golf Canada Member golf club* that issues *Golf Canada Handicap Factors* must have a *Handicap Committee* to ensure the integrity of the *Golf Canada Handicap Factors* issued by the Club.

Golf Canada (Score Centre Mobile) By GolfNet

Post your golf scores, look up a golfers' handicap factor(s), find golf courses in Canada, compute your course handicap and more. If you haven't downloaded the app for your iPhone or Android device, do so in 2017. You could get rewarded just for posting a score.

Handicap Seminars, Education and Licensing Agreements

As of 2016 there are two ways a club or individual can become certified under the handicap system:

- 1. is to attend a seminar in person, or
- 2. register and take the online handicap seminar on the Golf Canada website

10 members attended the Handicap Seminars held in Saskatoon and Regina on May 28th and 29th, 2016. Of the 10 people who challenged the exam, everyone received their certification. We also had 3 people take the ONLINE Handicap Seminar and all people passed the exam. The online seminar does have a cost however it is MAP Grant eligible.

In 2017, Handicap Seminars will again be held in Regina and Saskatoon on May 27th and 28th respectively. The office will notify member clubs who requiring recertification/certification and those who are required to sign the Handicap Licensing Agreement.

Golf SK has not met its goal of having 100% certification of all our member clubs however we are targeting an increase by the end of 2017. If your club has a certified Handicap Committee member, we would like more members to become certified, please

Increased Integrity in Handicapping

Handicapping is at the very core of equitable competition in amateur golf and few sports enable players to compete as equitably as golf. Handicapping is one of the Golf Saskatchewan's principal member services since the inception of our association back in 1913. All golfers who belong to Golf SK/Golf Canada through one of our member clubs or Public Player Program are eligible to receive an "Official" Handicap Factor.

The Handicap season for posting scores from Saskatchewan golf courses is April 15 to October 31. All games played outside the Active Handicap season in Saskatchewan should not be posted for your Handicap. You may post scores if you played at a course during an Active Handicap Season (I.E. Florida/Texas/Arizona in December). For more information consult the most recent Golf Canada Handicap System Manual.

RULES COMMITTEE

Member Club Rules Clinics

6 member clubs hosted a member club rules clinic in 2016. These sessions conducted at golf courses for the benefit of members, and are intended to familiarize golfers with the most frequently encountered rules situations and proper procedures. These seminars take the golfer from tee to green, covering the Rules an average golfer will encounter. If you have a "What If Question ..." or "What Happens When ..." the Member Club Rules Clinics is for you.

Golf Rule of the Week

Since 2009, to educate golfers on a variety of areas of the game we circulated a Golf Rule of the Week to all provincial media and interested people. The Rule of the Week has grown over the past 8 years and is now shared with more than 3,000 people with greater than a 52% open/read rate. The Rule of the Week will continue in 2017 and will be in your inbox starting the week of April 15^{th} . Remember – the Rules Matter!

Please note if you are interested in the starting your Rules of Golf education and progressing through the Golf Canada Rules Educational Pathway, please visit www.golfcanada.ca and select Rules. You don't have to be an expert on the rules, just show some interest. As there is a new code of Rules and Decisions there are a few items to review.

Provincial Level 3 Rules of Golf Seminar

In 2016, Golf Saskatchewan held the Level 3 Rules of Golf Provincial Seminar at the Willows Golf & Country Club in Saskatoon on Apr 22-24. A total of 13 people attended the weekend with 12 participants and 2 instructors. 4 out of the 6 participants challenged the exam gained their certification/re-certification mark. The certification/recertification mark is 85% and all attendees passed the exam.

In 2017, Golf Saskatchewan will hold the Provincial Level 3 Rules of Golf Seminar in Saskatoon on May 5-7. If you are looking to learn the rules of golf, we highly encourage members to register and start your rules education at www.golfcanada.ca.

Provincial on Course Training

In 2017, the provincial on course training seminar was not held. The seminar runs every two to three years and allows our volunteers a chance to learn best practices, proper methods of marking a golf course and new refereeing methodologies of assisting in the running of a championship.

National Level 4 Rules of Golf and Tournament & Rules Administration (TARS)

In 2016, Golf Canada National Level 4 Rules of Golf Seminar for the prairie provinces was held at the Niakwa CC in Winnipeg. Golf Saskatchewan had 2 attendees and 1 instructor who participated in the four-day session. Kevin Duchscherer, Evergreen GC in Nipwain, gained his certification mark.

In 2017, the Golf Canada National Level 4 Rules of Golf Seminar was held in Calgary at the Willow Park GCC. We had 1 attendee and 1 instructor who participated. Laurie Walker, Cooke MGC in Prince Albert, gained her certification mark.

In late April 2017, the second Tournament & Rules Administration Seminar (TARS) will be held in Vancouver. The National Rules Committee and Golf Canada Staff will put on a wonderful seminar with input and guest instruction from the USGA and R&A. More than 60 delegates from across Canada are planning on attending with 3 people from Saskatchewan.

SPORT DEVELOPMENT & CHAMPIONSHIPS COMMITTEE

Coaching & Sport Development

The PGA of Canada's coaching program is developed in partnership with Golf Canada and the Coaching Association of Canada (CAC). The PGA of Canada is one of 67 sports participating in the National Coaching Certification Program (NCCP), representing coaching and instructing excellence in Canada.

The PGA of Canada's NCCP is delivered with the goal providing coaches with the best practical experience in an optimal learning environment. As in any sport, athletic accomplishment and coaching are separate skillsets. Being a good athlete or accomplished golfer does not necessarily give an individual the skills for being an effective coach. The PGA of Canada's certification recognizes that a coach's teaching, technical and coaching skills all meet an internationally recognized standard for coaching practice. The PGA of Canada's NCCP is broken into three streams: Community Stream, Competition Stream, and Instruction Stream.

Golf SK has made Coaching a strategic imperative and we have contracted the services of Jason Schneider (CDC) and Amanda Minchin (CC facilitator) to be the coaching leaders for our province and work with our High Performance Development team.

HIGH PERFORMANCE - EXCELLENCE

High Performance Development Team - Easter Golf Camp

The 2016 golf season kicked off with the Easter Golf Camp back to Crown Isle Golf Club. Twelve junior players from across Saskatchewan attended the camp instructed by Coaches, Amanda Minchin and Jason Schneider. The feedback from the participants, parents and coaches was positive and was implemented into the plans for the 2017 camp. Many of the participants from 2016 joined the Golf Saskatchewan High Performance Development team (HPDT).



The 2017 Easter Golf Camp will be held at the Pheasant Glen Golf, Qualicum Beach BC. The participants are part of the Golf SK High Performance Development Team. The team started training in 2016 and will focus their efforts towards the 2017 Canada Summer Games and beyond. Although only part of the Development Team made it to BC, our Canada Games Team will be selected from members of the HP Development Team only.

The HPDT is a strategic change will can be expanded to additional Excellence programing moving forward. This is a fundamental change from our "traditional way" of doing things as we continued to do the same thing over and over again, expecting a different outcome.

National Athlete Assistance

The Sport Development Committee believes in our athletes competing and excelling at the highest levels. In 2013, the Athlete Assistance Program was revamped from an application process to an earned program. Following our Provincial Championships, athletes who qualify to attend nationals, either on teams/quota spots, are eligible to receive funding. The amount of subsidy is determined on an annual basis, however, more dollars are allocated towards players who make the team spots. In 2016, \$15,500 was provided in NAA along with \$40,000 in National Championship funding.

SAGE Scholarships

The program annually presents scholarships to assist deserving member golfers in their pursuit of high school and post-secondary academic excellence. The successful recipients are selected on their basis of academic excellence as well as some weighting of their golf participation. The two organization who pay the scholarship amounts are Golf Saskatchewan and the Saskatoon Community Foundation. Last year more than \$12,500 was awarded to 14 student athletes.

2017 Canada Summer Games



The 2017 Canada Summer Games will take place in Winnipeg, and it has been marketed as THE HOTTEST SUMMER IN HALF A CENTURY, JULY 28 - AUGUST 13, 2017. Featuring 16 sports, over 250 events and a major cultural festival, the 2017 Canada Games will welcome over 4,000 athletes and coaches and more than 20,000 visitors.

The Canada Games are this country's largest multi-sport event for young athletes and in 2017 will celebrate their 50th anniversary and Canada's 150th birthday. The 2017 Canada Summer Games will leave a lasting legacy of new and enhanced sport facilities, volunteer and leadership development that will benefit athletes and the broader community for years to come. The golf venue will be at the Southwood GCC.

The 2017 Canada Games will be one of the first competitions for the Golf Saskatchewan Development Team coached by Jason Schneider and Amanda Minchin. We hope to see positive results from more than one year of training, conditioning and championship preparation. Our best athletes from the program will represent Saskatchewan proudly.

North American Indigenous Games (NAIG 2017)

The 2017 planning for the North American Indigenous Games tryouts continues for Team Saskatchewan. The plan is to have two more work session with Golf Saskatchewan Coach, Jason Schneider, followed by a final selection competition in May. The team will then head for Toronto in August to take part in one of the largest Multi-Sport Games in North America.



Saskatchewan did well at the NAIG 2014 in Regina and we are looking to repeat these performances. More information about the athletes and games will be posted on the Golf Saskatchewan website.

National Golf in Schools:





This program has been developed for teachers to provide students the opportunity to develop aspects of "physical literacy" related to the sport of golf, and increase student knowledge and appreciation for the sport of golf.

In 2009, the National GIS program was a piloted in 15 elementary schools. As of 2016, there are 248 elementary schools, 6 intermediate schools and 50 high schools participating bringing the total to 304. This is an increase of 30 schools compared to 2015. We are currently in 40% of the 755 schools in Saskatchewan.

Golf SK's commitment to growing the sport is evident through this program. It would not be possible for Golf in Schools to have the success it has had without the school boards, schools, communities and member club's support.

How to get a GIS Kit? Some of the schools contacted our office and purchased kits, others were chosen to receive a kit based on school budget shortfalls and some schools have been adopted by a club or golf professional.

Healthy Lifestyle and Drug Awareness Days

In November each year, Golf Saskatchewan and Saskatoon Minor Hockey share a booth at the Prairieland Park to participate in the Healthy Lifestyles and Drug Awareness Days. More than 2,000 children grade 7-8 participate in the two-day session put on by the Saskatoon Police Services. We participate to show golf is a fantastic way to stay active, involved and decrease the chances of participating in high risk activities.

SoloRider

Sometimes people cannot play golf due to mobility issues related to age, change in life situation, health deterioration or an accident. The SoloRider is turning what used to be thought of as impossible into a reality. Athletes who have a mobility issue can now enjoy the stable, comfortable and fun way to get back in the game. The specialty cart enables golfers to continue to enjoy the game of golf. It allows the user access to:

The SoloRider and it is located at the Silverwood GC in Saskatoon. As of October 2016, 14 separate individuals used the cart at various times during the season including some who used it more than 8 rounds. There is no cost for the SoloRider other than the cost of a green fee. The staff at Silverwood GC will provide a quick tutorial for anyone wishing to use it. The City of Saskatoon also endorses the use of the cart as it is an inclusionary item for people with mobility impairments.

UPDATE: A second cart was purchased late in 2016 and will be located at the Royal Regina GC in 2017. We are looking forward to seeing the results of having two carts in 2017 and beyond.

1. Description of operations

Saskatchewan Golf Association Inc. ("Golf Saskatchewan" or the "Association") was incorporated under the Saskatchewan Non-Profit Corporations Act of Saskatchewan. The Association promotes and coordinates amateur golf in the Province of Saskatchewan.

2. Summary of significant accounting policies

The financial statements required management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the period. These estimates are reviewed periodically, and, as adjustments become necessary, they are reported in earnings in the period in which they become known. These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations. The financial statements reflect the following policies:

Inventory

Inventory is recorded at the lower of cost and net realizable value. Cost is determined based on the weighted average method.

Tangible capital assets

Tangible capital assets are recorded at cost less accumulated amortization. Amortization is provided on a declining balance basis over the estimated useful life of the assets at the following annual rates:

Computers	40%
Equipment	30%
Furniture & fixtures	30%

Revenue recognition

The Organization follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable, if the amount can be reasonably estimated and collections are assured. Revenues received from the Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreation are recorded as revenue in year to which the funding relates.

Donations in kind

Donations of material and services are recorded at fair market value when received if the amount can be reasonably estimated and would otherwise have been purchased.

2. Summary of significant accounting policies (continued)

Financial instruments - recognition and measurement

Financial assets and financial liabilities are recorded on the statement of financial position when the Association becomes party to the contractual provisions of the financial instrument. All financial instruments are required to be recognized at fair value upon initial recognition, except for certain related party transactions. All other financial assets, except for investments, and financial liabilities are subsequently measured at amortized cost adjusted by transaction costs, which are amortized over the expected life of the instrument. Investments are measured at fair value.

Fair value is the amount at which a financial instrument could be exchanged at arm's length between willing, unrelated parties in an open market. Changes in fair values of financial assets and financial liabilities measured at fair value are recognized in excess of revenues over expenses.

When there is an indication of impairment and such impairment is determined to have occurred, the carrying amount of financial assets measured at amortized cost is reduced to the greater of the discounted cash flows expected or the proceeds that could be realized from sale of the financial asset. Such impairments can be subsequently reversed if the value subsequently improves.

The RBC A+ Unified Managed Account is a structure which provides access to multiple investment managers within one account. The asset allocation of the account is set at 45% equities and 55% fixed income, with an emphasis on high quality securities, income generation, downside protection and capital preservation.

4. Investments (continued)

At December 31, 2016, the asset allocation in the account was \$10,892 in cash, \$152,244 in fixed income, \$172,402 in common shares, \$57,770 in mutual funds and \$11,526 in foreign securities.

At December 31, 2015, the asset allocation in the account was \$13,100 in cash, \$147,100 in fixed income, \$151,400 in common shares, \$56,900 in mutual funds and \$12,100 in foreign securities.

5. Sport Legacy Fund

The cash surrender value of the life insurance policy and investment in the Sport Legacy Fund consists of donations based on various programs and contributions by Sask Sport. These amounts are recorded as deferred revenue until amounts have been received. To qualify for an additional contribution by Sask Sport Inc., the Association is required to leave the original amount and any additional donations in the Legacy Fund for a minimum of five years.

6. Deferred revenue

During 2016, the Association received \$198,200 from the Saskatchewan Lotteries Trust Fund for expenses which will occur in the following fiscal year (2015 – \$193,900). Also, deferred revenue includes the funds invested with the Sport Legacy Fund of \$7,811 (2015 – \$3,931).

7. Economic dependence

Golf Saskatchewan currently receives revenue in grants from Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreation. As a result, the Association is dependent upon the continuance of these grants to maintain operations at their current level.

8. Income taxes

No provision for income taxes has been made in these financial statements as the Association is a non-profit organization and is exempt from income taxes under Section 149(1)(I) of the *Income Tax Act*. To the extent the Association maintains its non-profit status, no income taxes are expected to be payable.

9. Financial risk management

The significant financial risks to which the Association is exposed are:

Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Association is exposed to credit risk on the accounts receivable from its customers, however, does not have a significant exposure to any individual customer or member. The Association incurred \$716 in bad debt expense in the current year (2015 - \$7,519), but the expense in 2013 and 2014 was insignificant. Its customers are mainly members of the Association.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Association's exposure to liquidity risk is dependent on the receipt of funds from its operations and other related sources. Funds from these sources are primarily used to finance working capital and capital expenditure requirements, and are considered adequate to meet the Association's financial obligations.

Price risk

Price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. The Associations investments in publically traded securities expose the Association to market price risk as such investments are subject to price changes in the open market. The Association does not use any derivative financial instruments to alter the effects of this risk.

10. Comparative figures

Certain comparative figures have been reclassified to conform to the presentation in the current year.





