

NOTICE TO PLAYERS (NTP)

Lloydminster GCC, Lloydminster, SK | **July 8-10, 2025**The NTP supplements the entry form, Local Rules,
Terms of the Competition, and Standard Local Rules for 2025 events.



Play is governed by Rules of Golf (effective January 2023 – USGA/R&A/Golf Canada), the Local Rules and Terms of the Competition for the PGA TOUR AMERICAS competitions and qualifying rounds, and, where applicable, by following Terms and Local Rules. Local Rules posted our used at the host club or local rule on the host club scorecard do not apply. Unless otherwise noted, the penalty for breach of a Local Rule or Term is the General Penalty - Two Strokes.

1. TEE-MARKERS & WASHROOMS

- Junior Women (U19,17, 15) Red
- JR Women & JR Men (U13) Silver/Grey
- Junior Men (U19 and U17) Green
- Junior Men U15 White

- JR-JR Competition are in the fairway of the hole being played.
- Washroom portable washrooms on the course.
- Shelters multiple gazebos on the course however the preference is to get back to the Club House
- **2. PACE OF PLAY:** Time PAR is 4:35. (2:15 + 2:15 + 5 minutes at the turn)
- 3. **DESIGNATED PRACTICE AREA** practice is permitted in the following areas:
 - a. Practice putting green beside the 1st tee and the chipping green at/on the driving range **NOTE** use discretion and a reasonable distance inside of 3 club lengths from edge of green.
 - b. The penalty for practicing on the competition course before or between competition rounds is **disqualification**.
- **4. OUT OF BOUNDS (OB):** is marked by the perimeter fencing or white stakes/posts includes the maintenance area in the fenced area and the Driving range. The green fence up Hole 10th is OB.
- **5.** ABNORMAL COURSE CONDITIONS (ACC): Hole #3 and 18 → These holes there are ACC from 150 yards to the front of the putting green. If your ball lies on a bare spot, play the ball as it lies **or** within 1 club length of and not nearer the hole, the ball may be played under preferred lies. A ball one placed is in play and cannot be replaced, unless the player is allowed to proceed under another rule.
- **6. NEWLY PLANTED TREES:** N/A
- 7. NO PLAY ZONE: Flower Gardens Nearest Point of Relief.
- **8. TEMPORARY IMMOVABLE OBRUCTIONS:** any Starting or Scoring Tent(s) are Temporary Immovable Obstructions. Model Local Rule F23 is in effect.
- **9. IMMOVABLE OBSTRUCTIONS CLOSE TO THE PUTTING GREEN:** Model Local Rule F-5 is in effect. The player may take relief under Rule 16-1b if an immovable obstruction is on the line of play and is on or within two club-lengths of the putting green, and within two club-lengths of the ball.
- **10. RED PENALTY AREAS:** in the absence of sight lines between stakes or a red line, the grass line will be used as the margin of the Red Penalty Area.
- **11. DROP ZONES (DZ):** No drop zones are listed for this event.
- **12. EVACUATION PLAY:** in the event of a suspension of play for a dangerous situation (signaled by one blast of an air horn), players must stop play immediately and move to the clubhouse asap.
- **13. SCORING AREA:** will be located at the clubhouse on the lower level.

14. SCORECARD RESPONSIBILITIES

- a. **Scorecard Returned** The scorecard of a player or a side is returned to the Committee 15 minutes after the scorecard is accepted into the electronic scoring system. See Supplemental Notice to Players for all relevant information.
- b. <u>Missing Player or Marker Certification</u> Model Local Rule L-1 is in effect and Rule 3.3b(2) is modified as follows If a player returns a scorecard without the hole scores being certified either by the player, the marker or both, the player gets the General Penalty. The penalty applies to the last hole of the player's round.
- **15. PLAYOFF:** In the event of a tie for the individua/team championships or medals a hole-by-hole playoff will take place on hole(s) to be determined by The Committee and will be repeated if needed until a winner is declared. See Tie-Breaking Procedure on the Golf Saskatchewan website.
