



NOTICE TO PLAYERS (NTP)

Golf Kenosee, Kenosee Lake, SK | July 14-16 | 17, 2026

The NTP supplements the entry form, Local Rules,
Terms of the Competition, and Standard Local Rules for 2026 events.



Play is governed by Rules of Golf (effective January 2023 – USGA/R&A/Golf Canada), the Local Rules and Terms of the Competition for the PGA TOUR AMERICAS competitions and qualifying rounds, and, where applicable, by following Terms and Local Rules. **Local Rules posted or used at the host club or local rule on the host club scorecard do not apply.** Unless otherwise noted, the penalty for breach of a Local Rule or Term is the **General Penalty - Two Strokes.**

1. **TEE-MARKERS & WASHROOMS**

-  Amateur & Mid-Am Women – **Red**
-  Amateur & Mid-Amateur Men – **Green**
-  Washroom – In-between 5 & 8 tee box. And 12 tee.

2. **PACE OF PLAY:** Time PAR is 4:35. (2:15 + 2:15 + 5 minutes at the turn)

3. **DESIGNATED PRACTICE AREA** – practice is permitted in the following areas:

- a. Practice putting green beside the 1st tee and the chipping green at the driving range
NOTE - use discretion and a reasonable distance – inside of 3 club lengths from edge of green.
- b. The penalty for practicing on the competition course before or between competition rounds is **disqualification.**

4. **OUT OF BOUNDS (OB):** is marked by the perimeter fencing or white stakes/posts

5. **ABNORMAL COURSE CONDITIONS (ACC): Hole #1 and #10.** These holes are ACC. If your ball lies on a bare spot, play the ball as it lies **or** within 1 score card length of and not nearer the hole, the ball may be played under preferred lies. A ball once placed is in play and cannot be replaced, unless the player is allowed to proceed under another rule.

- a. **Boxed Areas:** Hole 6, 9, 15, 17.

6. **NO PLAY ZONE:** Flower Gardens – Nearest Point of Relief. Green Nursery end of 12th fairway

7. **TEMPORARY IMMOVABLE OBSTRUCTIONS:** any Starting or Scoring Tent(s) are Temporary Immovable Obstructions. Model Local Rule F23 is in effect.

8. **IMMOVABLE OBSTRUCTIONS CLOSE TO THE PUTTING GREEN:** Model Local Rule F-5 is in effect. The player may take relief under Rule 16-1b if an immovable obstruction is on the line of play and is on or within two club-lengths of the putting green, and within two club-lengths of the ball.

9. **RED PENALTY AREAS:** in the absence of sight lines between stakes or a red line, the grass line will be used as the margin of the Red Penalty Area.

- a. **Hole #11-** Left side from bridge to green
- b. **Hole #13-** Right Side from FW Bunker to back of Green
- c. **Hole #15-** Right Side all the way down and around back of green

10. **DROP ZONES (DZ):** Hole #15- If hit in Penalty Area behind green. You may go to Drop Zone Drop within 1 club length of stick.

11. **EVACUATION PLAY:** in the event of a suspension of play for a dangerous situation (signaled by one blast of an air horn), players must stop play immediately and move to the clubhouse asap.

12. **SCORING AREA:** Past 18th hole. Tent will be set up.

13. **SCORECARD RESPONSIBILITIES**

- a. **Scorecard Returned** – The scorecard of a player or a side is returned to the Committee 15 minutes after the scorecard is accepted into the electronic scoring system. See Supplemental Notice to Players for all relevant information.
- b. **Missing Player or Marker Certification** – Model Local Rule L-1 is in effect and Rule 3.3b(2) is modified as follows – If a player returns a scorecard without the hole scores being certified either by the player, the marker or both, the player gets the General Penalty. The penalty applies to the last hole of the player's round.

14. **PLAYOFF:** In the event of a tie for the individual/team championships or medals a hole-by-hole playoff will take place on hole(s) to be determined by The Committee and will be repeated if needed until a winner is declared. See Tie-Breaking Procedure on the Golf Saskatchewan website.
